Test substrate was calcium silicate board meets the requirement of EN13501-1, of Class A2-s1, d0, the density of 900 kg/m³ and thickness of 10mm.

Specimen was installed on the substrate by screw. There was no joint between specimens. Specimen had a distance of at least 80mm from the backing board.


